India produces 500-550 million tonnes of crop residue every year. In the states of Punjab and Haryana, 35 millions tonnes of paddy straw is left over after harvesting, most of which is burned. This residue burning causes serious air pollution that is responsible for public health emergencies in the capital of India (Delhi) every winter.

Key Message to the Investors :

We are the first company in India to commercialize products made out of 100% paddy straw. We work with government, corporates and R&D institute for solving the paddy straw burning problem and take our innovative products out of the straw. In the first stage we have setup models to track fires and then optimise our collection process. From the collected straw we have commercialized two products - energy pellets and GreenCoal to replace fossil fuel in thermal power plants. We will be exploring funding options to scale up our operations.
